

AN ACT

To enact section 123.29 of the Revised Code and to amend Sections 369.10 and 369.314 of Am. Sub. H.B. 64 of the 131st General Assembly, as subsequently amended, to require the Chancellor of Higher Education to create the SmartOhio Financial Literacy Pilot Program at the University of Cincinnati to operate for the 2016-2017 school year, to establish the Task Force for Creating Opportunities for Shared Governance on Co-Located Campuses, to provide support for the Ohio Youth Entrepreneur Program at Youngstown State University, to rename the Capitol Theatre of the Vern Riffe Center for Government and the Arts as the Speaker Jo Ann Davidson Theatre, and to make an appropriation.

Be it enacted by the General Assembly of the State of Ohio:

SECTION 1. That section 123.29 of the Revised Code be enacted to read as follows:

Sec. 123.29. The theater in the Vern Riffe center for government and the arts in Columbus, formerly known as the capitol theatre, shall be known as the Speaker Jo Ann Davidson theatre.

SECTION 2. The Speaker Jo Ann Davidson Theatre is successor to, assumes the obligations and authority of, and otherwise continues the Capitol Theatre in the Vern Riffe Center for Government and the Arts. No right, privilege, or remedy, and no duty, liability, or obligation, accrued under the Capitol Theatre is impaired or lost by reason of the renaming and shall be recognized, administered, performed, or enforced by the Speaker Jo Ann Davidson Theatre.

Except as otherwise provided in law, whenever the Capitol Theatre of the Vern Riffe Center for Government and the Arts is referred to in a statute, rule, contract, or other instrument, the reference is deemed to refer to the Speaker Jo Ann Davidson Theatre.

SECTION 3. (A) The Chancellor of Higher Education shall create the SmartOhio Financial Literacy Pilot Program at the University of Cincinnati to operate for the 2016-2017 school year. Under the pilot program, the Chancellor shall provide funding, as appropriated by the General Assembly for this purpose, for the development and implementation of regional financial education programs with the goal of increasing financial literacy for students in grades kindergarten through eight.

(B) The regional financial education programs shall be operated by the University of Cincinnati and delivered through a joint partnership between the Ohio Council on Economic Education and OSU Extension.

The partnership shall do both of the following with regard to the programs:

(1) Develop curricula and instructional materials that do all of the following:

(a) Provide age-appropriate education to students in grades kindergarten through eight to promote financial literacy at an early age;

(b) Enable students to develop the skills necessary to develop and maintain a budget, understand credit and investments, and use the banking system;

(c) Integrate financial literacy education into the existing curriculum on mathematics and English language arts.

(2) Provide teacher training and professional development opportunities on these curricula and instructional materials to enable teachers across the state to provide financial literacy education to students in grades kindergarten through eight.

SECTION 4. (A) There is hereby established the Task Force for Creating Opportunities for Shared Governance on Co-Located Campuses. The Task Force is charged with creating a model for shared governance for co-located campuses. A co-located campus is one in which a community college and regional branch of a four-year institution of higher education are located on the same or adjoining campuses. The model created by the Task Force is to emphasize shared administration, student services, maintenance, facility usage, and other shared governance to better serve the students while preserving the individual academic missions of the college and institution.

(B) The Task Force shall consist of nine members as follows:

(1) A member of the Senate appointed by the President of the Senate;

(2) A member of the House of Representatives appointed by the Speaker of the House of Representatives;

(3) A member of the Ohio Board of Regents appointed by the Governor, which member shall serve as chairperson of the Task Force;

(4) A board member of a four-year institution of higher education that has a co-located branch campus, appointed by the President of the Senate;

(5) A board member of a two-year community college that is located on a co-located campus, appointed by the Speaker of the House of Representatives;

(6) An administrator of a four-year institution of higher education that has a co-located branch campus, appointed by the President of the Senate;

(7) An administrator of a two-year community college that is located on a co-located campus, appointed by the Speaker of the House of Representatives;

(8) One representative of small businesses, appointed by the President of the Senate;

(9) One representative of large businesses, appointed by the Speaker of the House of Representatives.

(C)(1) Members of the Task Force shall serve without compensation, but actual expenses incurred in the discharge of their duties, including mileage, may be reimbursed by the Department of Higher Education.

(2) Vacancies on the Task Force shall be filled in the same manner as the original appointment.

(D) The Department of Higher Education shall provide necessary staff, facilities, supplies, and services to the Task Force.

(E) The Task Force shall submit its recommended model to the Governor, the President and Minority Leader of the Senate, and the Speaker and Minority Leader of the House of Representatives not later than November 1, 2016. Upon submission of the model, the Task Force shall cease to exist.

SECTION 5. That Sections 369.10 and 369.314 of Am Sub. H.B. 64 of the 131st General

Assembly, as amended by Sub. H.B. 340 of the 131st General Assembly, be amended to read as follows:

Sec. 369.314. HIGHER EDUCATION PROGRAM SUPPORT

Of the foregoing appropriation item 235533, Higher Education Program Support, \$250,000 in each fiscal year shall be used by The Ohio State University to support its hosting of the annual Special Olympics Ohio Summer Games.

Of the foregoing appropriation item 235533, Higher Education Program Support, \$100,000 in each fiscal year shall be used to support program development and equipment purchase expenses for the Cores + Connections program at the Cleveland Institute of Art.

Of the foregoing appropriation item 235533, Higher Education Program Support, \$100,000 in each fiscal year shall be used by Eastern Gateway Community College to establish and provide scholarships under the Energy Sector Scholarship Pilot Program. The program shall seek to incentivize and connect high school students with scholarship opportunities to pursue careers in the oil and gas industry in Ohio. Staff from Eastern Gateway Community College shall provide administration, outreach, and marketing for the program.

Of the foregoing appropriation item 235533, Higher Education Program Support, \$75,000 in each fiscal year shall be distributed to the Ohio University Leadership Project.

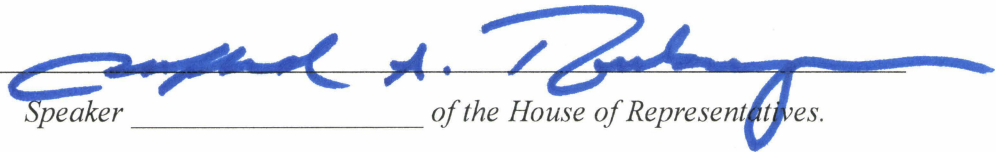
Of the foregoing appropriation item 235533, Higher Education Program Support, \$75,000 in each fiscal year shall be used to establish the Customized Employee Recruitment Workforce Program at Sinclair Community College.

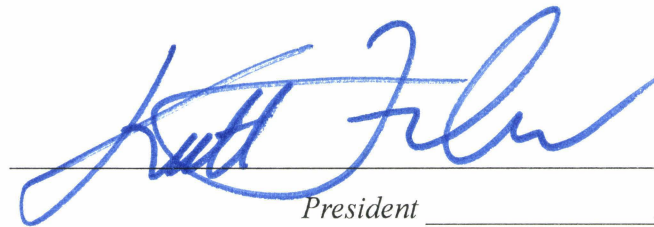
Of the foregoing appropriation item 235533, Higher Education Program Support, \$220,000 in fiscal year 2016 shall be used by Wright State University for security upgrades necessary for hosting the presidential debate in the fall of 2016.

Of the foregoing appropriation item 235533, Higher Education Program Support, \$318,000 in fiscal year 2017 shall be used to support the SmartOhio Financial Literacy Pilot Program at the University of Cincinnati.

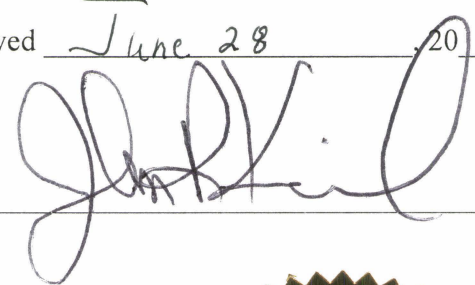
